

	The difference between the global organizational schema from the local one is that the universal level is used by writers to organize information in a general fashion rather than pinpointing a specific position. They revise documents on a larger scale ar arrange the data, so it surrounds the audience and serves the purpose of the message is. While Local-level deals more on a specific set of information organized with proper diction and sentence structure. It follows an inductive order, using precise knowledge and focusing on minimal details. Local organizational schema focuses on the refinement of documents, it can also b called a grammatical perspective.	
	Chronological order: This is the practice of organizing information according to the sequence of the events, actions that occur. uses patterns to present data to the audience for better understanding and to tell stories.	lt
	Spatial Order: Information is structured according to the description of the location. It describes things in a particular space from one area to the other to know its structure. For example, Behind the counter is a washing machine and in front of it is a dryer. It allows a writer to create visual imagery to present knowledge to the audience.	
	Logical order: It is the presentation of data in a rational format. The first information presented must be processed and explaine before the next one. Documents are shown in a sequence based on the first item in the group. For example, when writing a narrative, you can't jump from the beginning to the moral of the story without explaining what happened in the middle. It leaves the conclusion open, weak, and simple to argue the claim.

## Discussion post three - Classical arguments.

This was surprisingly a useful skill needed. I already knew the concept behind the three rhetorical appeals but up until this lecture, I did not realize how critical it was especially since I would require it for my research report. The use of Ethos and Logos not only provided general knowledge but it served as an insight into the importance of credibility. Writers need facts, evidence proper sources to create an argument for their work, so it resonates with the intended audience. This is where the rhetorical appeals come into place, with Ethos for credibility which serves as sources it shows that experiences are more likely to win over an audience. With the use of logos that contain facts and evidence, it is easier to convince the people that the argument being made is true and not an opinion. Using both appeals in my essay made the work much more persuasive in supporting my claims.

The structure of a great speech
The three modes of persuasion constructed by Aristotle is a proper structure for Oral Argument. Each appeal uses a dispute that resonates with the audience well. Ethos establishes credentials to the public with knowledge matter or with experience for precise credibility. Logos is the use of facts and Logic to strengthen the discourse, usage of this mode to back up a claim, or credibility to stand well with the audience. Pathos uses emotion within the viewers to connect them to the topic of the debate.
Familiarity with the viewers helps the writer make proper arguments. When they know their audience, they can formulate a case that resonates well and convinces the viewer's perspectives. With Ethos, Pathos, and Logos, they can persuade with credibility relatable to the audience because the use of common wisdom accepted by the specific audience appeals to the senses. The practice of common beliefs associated with the premises allows influence. General opinions embedded in Arguments can change the views of the audience.
